Pit was drained and is being prepared for decommissioning. Drill cuttings, liquids, the synthetic liner and any stained soil beneath the liner will be excavated and tested for Table 910-1 parameters. These cuttings will then be stockpiled on site before landfarming begins. Upon removal of water in the pit, a composite sample will be collected from the pit bottom materials to evaluate compliance with Table 910-1 standards for this material.
