Consult with the local Natural Resource Conservation Service on a seed mixture that matches the adjacent land or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than 5/31/2017.
