I've attached historic Google Earth images from 1993 and 2011 showing one pit on location (facility 100695, Wexpro Company is currently working with COGCC to close this pit). Also attached is a site security diagram of the Carl Allen 17 well pad from 2009 showing one pit as well (100695). Pit 116706 shows the same GPS coordinates as pit 100695 in COGCC database. I believe that this pit, 116706, was a duplicate created in error.
Wexpro Company requests closure and NFA of facility 116706.
