Comment: There are large areas on the southern end of the location that remain unvegetated with little desirable perennial growth evident. These areas will require additional reclamation work. See photos 6, 7 and 10. Straw wattles used as a stormwater and sediment control BMP have not been maintained and are considered debris. See photo 4. Cattle guard on access road has not been removed. See photos 11 and 12.

Corrective Action:	Repair or remove and properly dispose straw wattle BMPs currently in disrepair on location. Remove cattle guard. Perform additional reclamation on unvegetated areas of location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To take advantage of the 2017 spring growing season, revegetation activities shall be complete no later than 5/31/2017.	Date	05/31/2017
