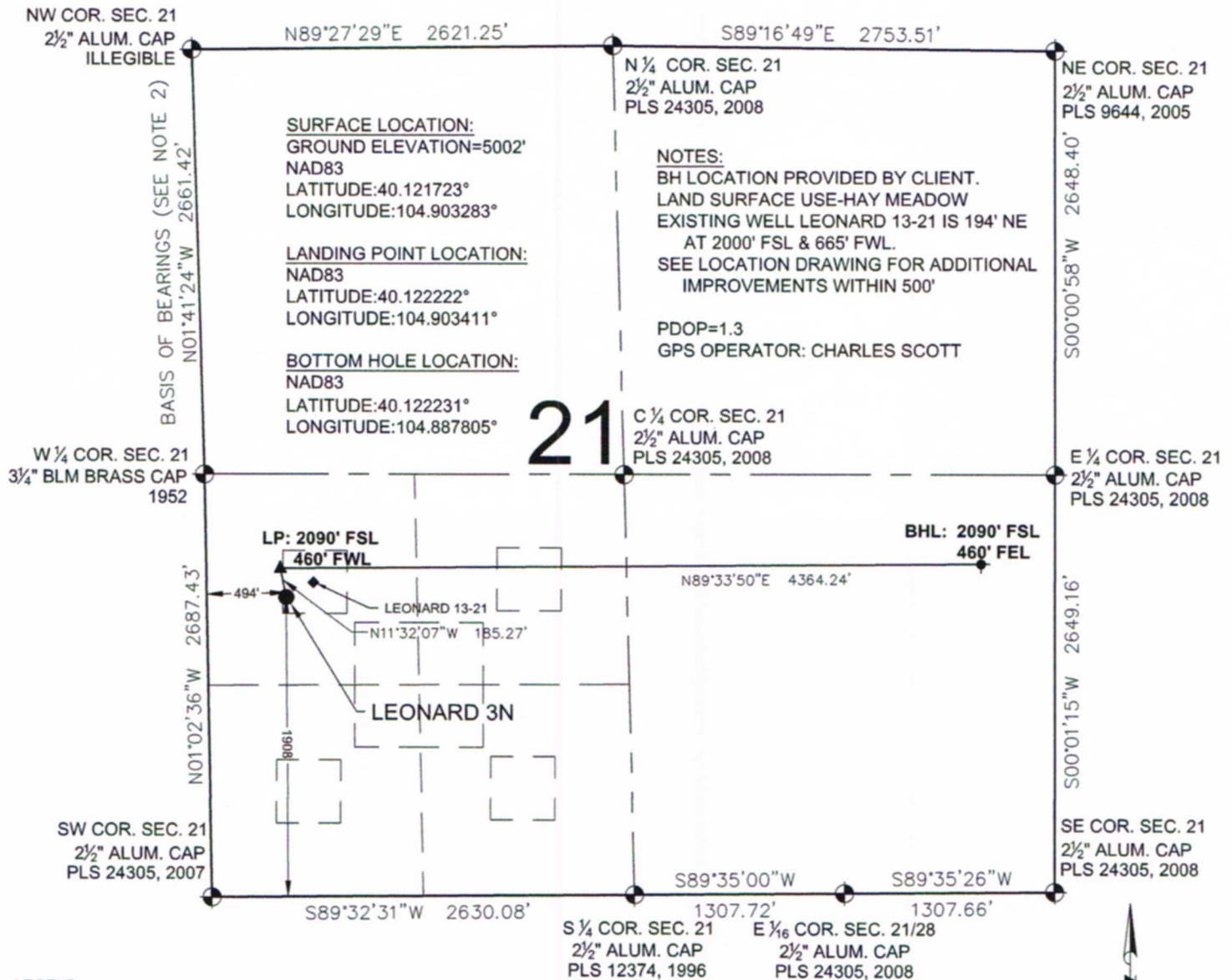


LEONARD 3N WELL LOCATION CERTIFICATE

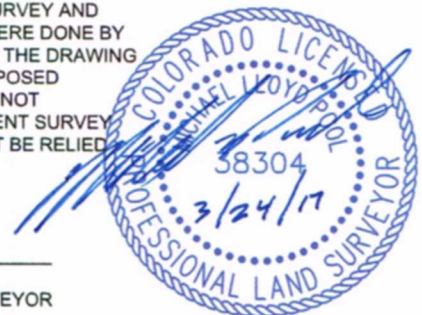
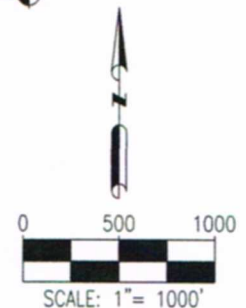
