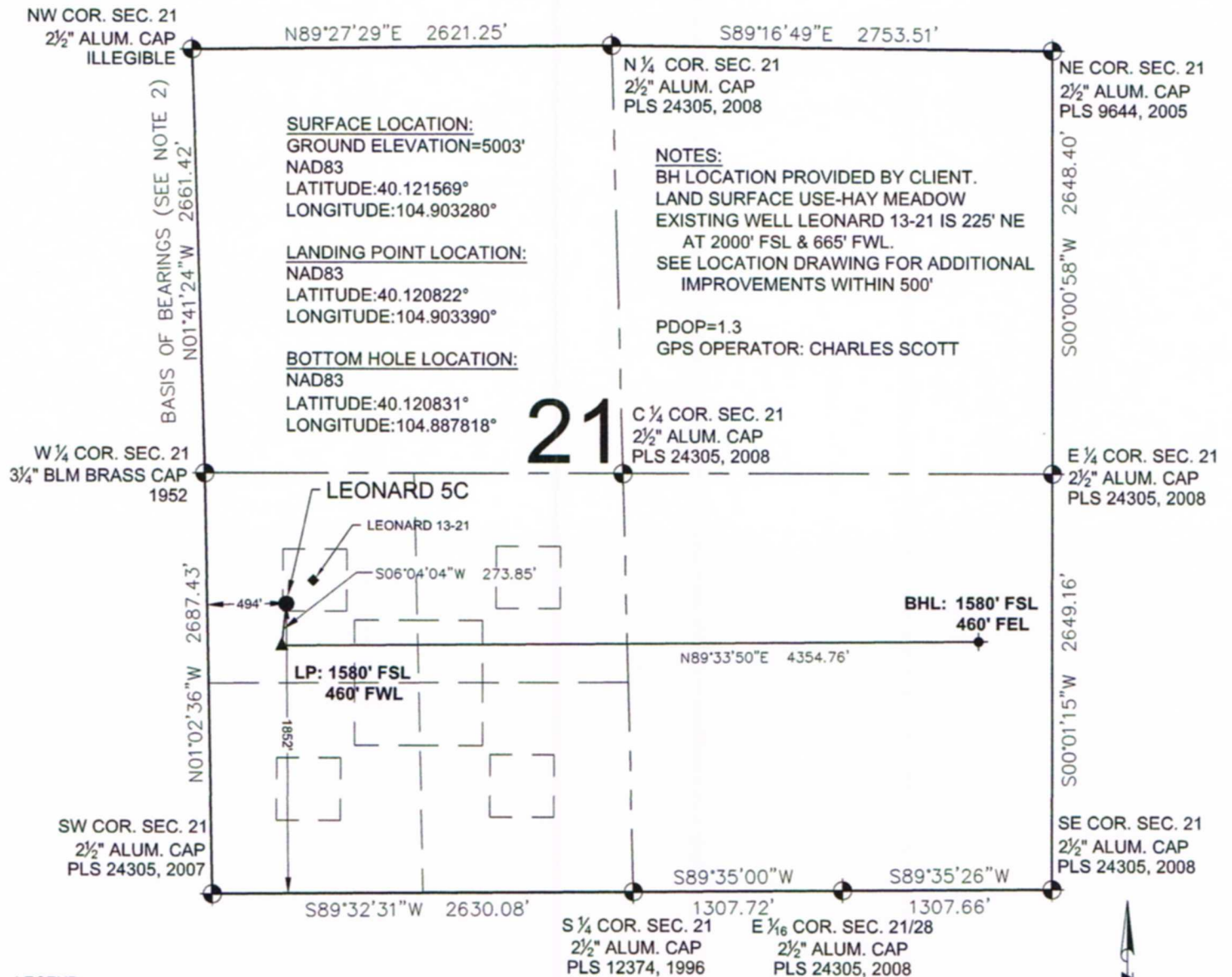


# LEONARD 5C WELL LOCATION CERTIFICATE

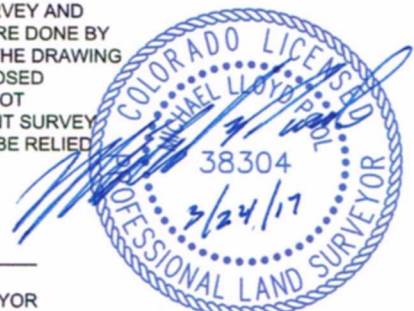
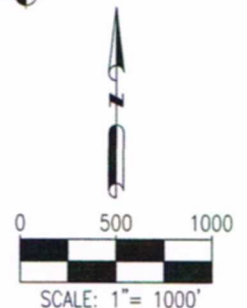
