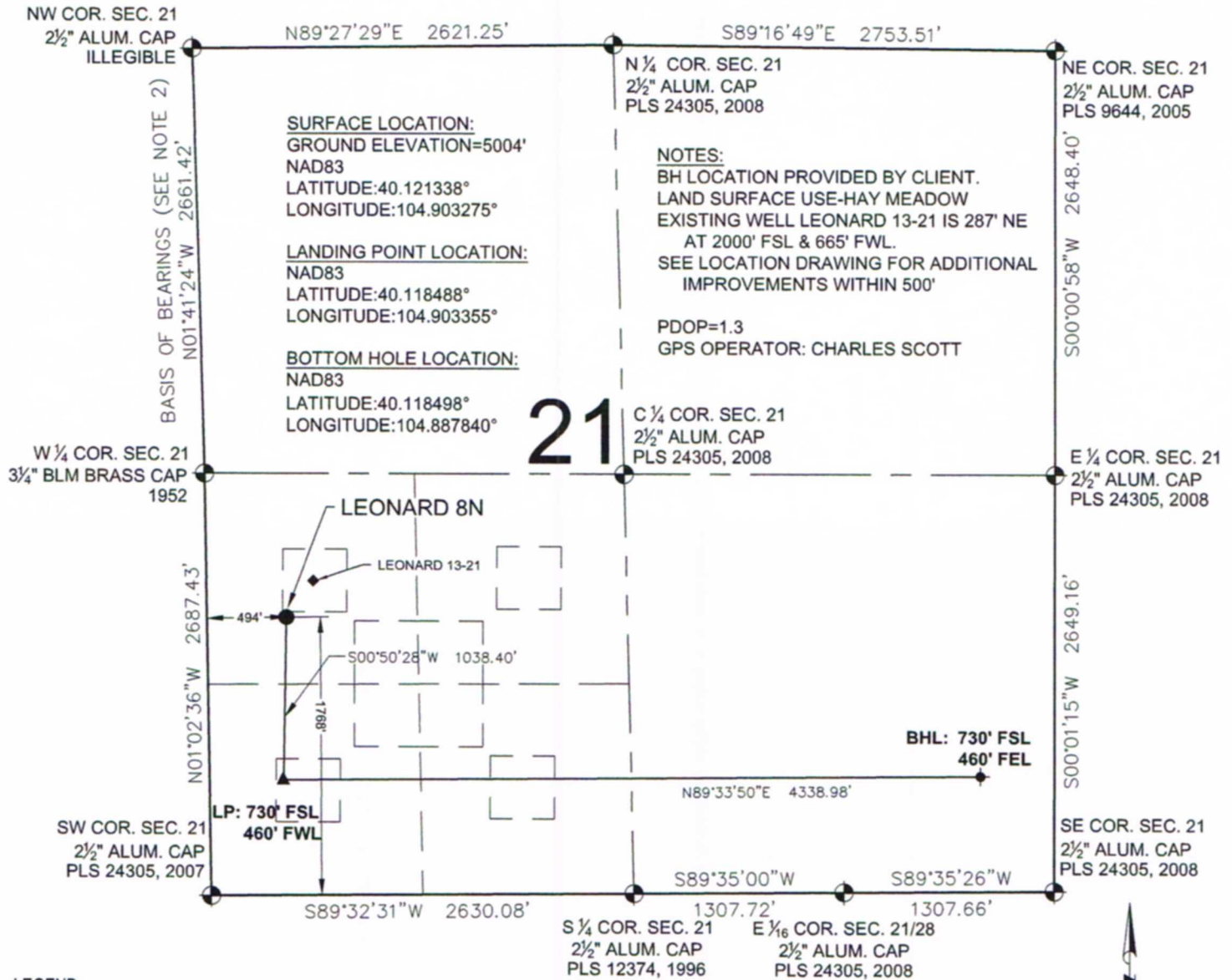


LEONARD 8N WELL LOCATION CERTIFICATE



WELL LEONARD 8N TO BE LOCATED 1768' FSL & 494' FWL

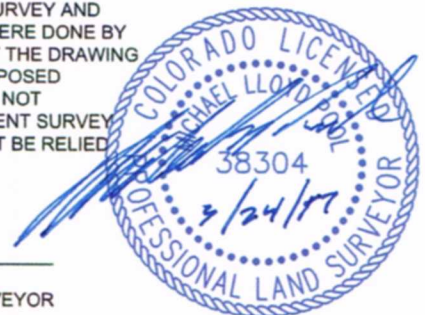
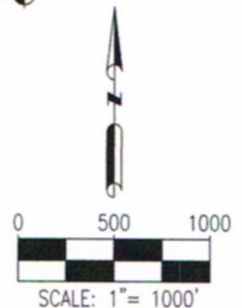
NOTES:
