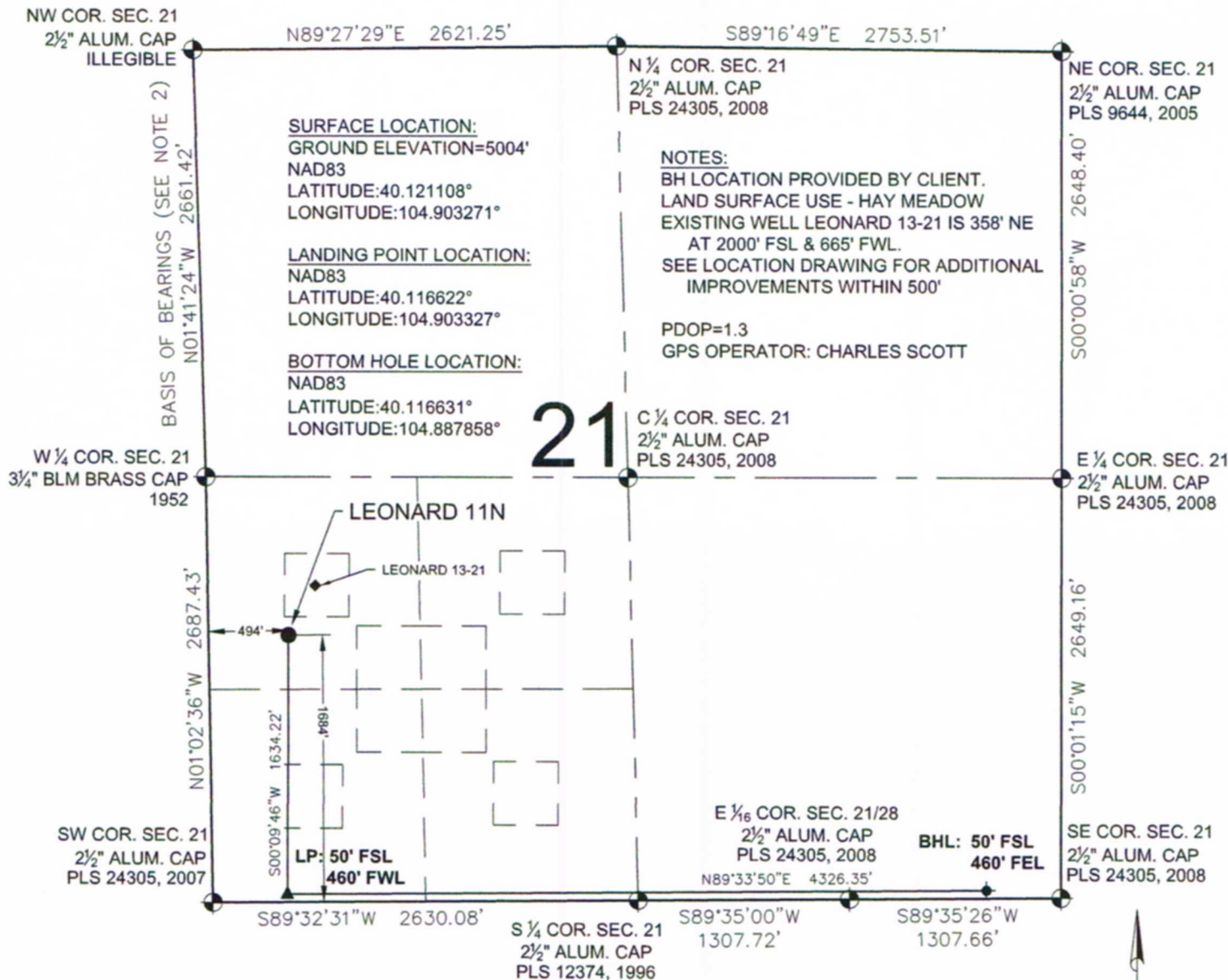


LEONARD 11N WELL LOCATION CERTIFICATE

WELL LEONARD 11N TO BE LOCATED 1684' FSL & 494' FWL

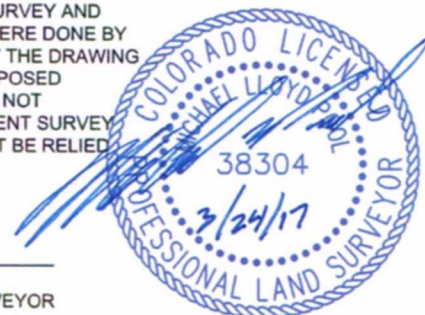
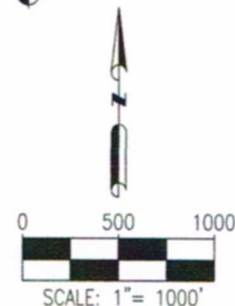
