Comment: Topsoil salvaged and stored along the western perimeter of location. Topsoil did not appear to be evenly salvaged throughout portions of the location. Some areas only appeared to be salvaged to a depth of 3"-4". An Operator representative was on location and agreed that additional topsoil should be salvaged and would communicate that to the contractor. Per Rule 1002, topsoil shall be stabilized and protected from degradation due to wind and water erosion. Per Rule 1002, BMPs to prevent weed establishment and to maintain soil microbial activity shall be implemented.
