Perform reclamation per COGCC 1000 series rules and standards; Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To take advantage of the 2017 spring growing season, revegetation activities shall be complete no later than 5/31/2017.
