	<p>Inspection Doc. #682500988 documented gravel still remaining on location as well as pipe and that a large area on the southern end of the location remains bare with erosion evident. This inspection required that gravel and pipe need to be removed, and that these areas need to be stabilized and reclaimed. These corrective actions have not been addressed; location remains unstabilized with erosion evident. Pipe debris and gravel still remain. No evidence that any reclamation activities have taken place. See attached photos. Original CA and CA dates remain in place.</p>	
Corrective Action:	<p>Perform reclamation; Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2016</p>	Date <b>11/15/2016</b>
