COMMENTS:

PDC requests the removal of the COA requiring option 1 or 2 mitigation be done on the O'Grady 43-4 prior to frac from the McGlothlin Farms APDs (API #123-44009). Because surface casing is set at 386', the deepest water well in the area is ~400' deep and an annular fill was done from 100'- 3396' in 2010, PDC believes that Option 4 remediation on this well with be sufficient. We intend to pressure test and test the bradenhead prior to the commencement of the McGlothlin Farms pad frac. Will pressure test at 2000-2500 psi for 15 minutes.
