General Comment:

This is a Reclamation focused Inspection. Inspection was prompted by Variance Request Doc#401103990 submitted by Operator asking for Variance of Final Reclamation; leaving Pad un-reclaimed for Land Owner use as Agricultural Storage site. This inspection is to document conditions and compliance with Stormwater, Erosion and Noxious Weed 1004 series Rules. A Final Reclamation Inspection will be conducted if Variance is approved.

Landowner stated that use of the Pad was now an integral part of his Farming Operation. They are now producing Organic Alfalfa Hay for Dairies on the Front Range which has to meet the highest standards. The buildings erected on the Location now provide safe, dry, covered storage for the Hay. In prior years hay had to be stacked in field & quality would deteriorate making it unacceptable to the Dairies.
