PROCEED IN A WESTERLY DIRECTION FROM MEEKER, COLORADO ALONG U.S. HIGHWAY 13 APPROXIMATELY 2.0 MILES TO THE JUNCTION OF THIS ROAD AND STATE HIGHWAY 64 TO THE NORTHWEST; TURN RIGHT AND PROCEED IN A NORTHWESTERLY DIRECTION APPROXIMATELY 26.3 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 77 TO THE NORTH; TURN RIGHT AND PROCEED IN A NORTHERLY THENCE EASTERLY DIRECTION APPROXIMATELY 6.1 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 71 TO THE EAST; PROCEED ON COUNTY ROAD 71 EASTERLY THENCE NORTHERLY APPROXIMATELY 2.1 MILES TO THE JUNCTION OF THIS ROAD AND A PRIVATE ROAD TO THE NORTH; PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 1.8 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTHWEST; TURN LEFT AND PROCEED IN A NORTHWESTERLY THENCE WESTERLY DIRECTION APPROXIMATELY 1.3 MILE TO AN EXISTING TWO TRACK ROAD TO BE UPGRADED TO THE WEST; CONTINUE IN A WESTERLY DIRECTION APPROXIMATELY 3,681' TO THE BEGINNING OF THE PROPOSED ACCESS TO THE SOUTHWEST; FOLLOW THE ROAD FLAGS IN A SOUTHWESTERLY DIRECTION APPROXIMATELY 296' TO THE PROPOSED BHR FED J22-397 PAD.

TOTAL DISTANCE FROM MEEKER, COLORADO TO THE PROPOSED BHR FED J22-397 PAD IS APPROXIMATELY 40.2 MILES.






