Germination and desirable plant establishment within the fenced location appears to be progressing; however areas outside of the fence appear to be progressing more quickly. There is a strong possibility that noxious weeds are present within the fenced reclamation area as ~5-6 rosettes were found. Will need to monitor, until more pronounced and defining features of the plant become evident and allow for a more accurate ID. Reclamation specialist has two theories as to how the alleged weeds may have become present on location: One possibility is seeds may have been present on the equipment used during reclamation, however, if this was true, one would expect to see rosettes along other areas where reclamation was conducted; rosettes were only found within the fenced area. The second possibility is it may have been present within the corn stalk mulch as this mulch had only been used within the fenced area. This could also explain the presence of other weedy species found such as the pigweed, amaranth species documented on site; it is common practice for livestock producers to graze on cornstalks during certain times of the year. Livestock may introduce certain weedy species into these croplands through their manure. Reclamation specialist is unsure as to what regulations exist regarding certified weed free status for corn stalk mulch, or if such regulations exist. Will follow up with contractor and the Colorado Department of Agriculture regarding these questions.	trujilloam	04/21/2017
