Comment:

Inspection conducted in response to communication with Tracy Perfors (BLM) regarding a potential landfarm on a location P&A circa 1995. Site appears to be an abandoned landfarm. Soils are spread ~1.5 ft thick on top of deteriorated HDPE liner. Soils have degraded petroleum odor. Spoke with Andrew Winney of Operator (Samson Resources) on 4/28. He stated that Samson never operated a landfarm on this location and believes contaminated soil was hauled to the location by another operator. COGCC database shows no records of spills or remediation from this or nearby wells within ~ ¼ mile radius. Samson collected soil samples exceeding Table 910-1 for TPH. Informed Andrew of COGCC F-19 and F-27 reporting requirements and necessary remediation.

Corrective Action:

Samson will submit F-19, haul contaminated soil and liner to landfill, collect confirmation samples and confirm cleanup with a Supplemental F-19. Following spill closure, Samson will complete reclamation per BLM and COGCC 1000 series rules.
