The sales line does not flow to the atmosphere during normal operations.
The only instance that it is open to the atmosphere is when de-pressurizing the sales line.
The exact duration cannot be stated because it depends on the volume of fluid in the line.

COMMENTS:

The source of the hydrogen sulfide (H₂S) was determined to be the production separator associated with this well. In response, it was treated with H₂S scavenger after field measurements confirmed the presence of H₂S. The following day, March 15, 2017, the sales line was re-sampled via field measurement techniques and H₂S was not observed.
