	<p>Transect conducted during inspection #682501189 indicated vegetation is not 80% of the surrounding reference area. See inspection #682501189 for additional details. Unable to find any evidence that additional reclamation activities have taken place; Bare areas remain without any evidence of desirable perennial vegetative germination. An abundance of undesirable weedy plant species evident throughout location. Reclamation specialist had also not received a form 42 indicating corrective actions have been addressed as requested by inspection doc.#682501189. Original CAs and CA date remains in place.</p>	
Corrective Action:	<p>Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2016.</p>	<p>Date <b>11/15/2016</b></p>
