


BASIS OF BEARING:

STAMPED "LS 24670" AND THE WEST QUARTER CORNER OF SECTION 21 MONUMENTED WITH 3 1/4" A.C. IN R.B. STAMPED "LS 4392" BASED ON THE COLORADO NORTH 0501 STATE PLANE COORDINATE SYSTEM.

ELEVATIONS ARE BASED ON NAVD 88, AS OBSERVED FROM GPS OBSERVATIONS




