Proposed Procedure:

1. MIRU Service rig
2. RIH Tag fill
3. POOH while tallying and Tuboscoping tbg, lay down tbg.
4. RIH w/ cast iron kill plug and set at appx 8185. Dump bail cement on top of plug.
5. Pressure test csg to surface to 9500psi for 15 mins.
6. Frac MVRD
7. Drill out all plugs to kill plug at 8185 and circulate clean.
8. Land tbg at appx 8030'.
9. Return well to production. Drill out final kill plug and commingle at later date.
