Comment: Sediment is filling along wattles in the western portion of the project area. There is a portion of the western fill slope that has exposed soils, appears to be eroding, and stormwater controls are not in place. See attached photos.

Corrective Action: Erosion controls along the western edge of the fill slope need maintenance. Additional controls are needed along the slope where it is eroding. Successful revegetation of this area is the best way to stabilize. However, stormwater controls are needed for short-term stabilization.
