Whiting Oil and Gas Corporation (Whiting) respectfully requests ID 335952 be changed to an abandoned location for the following reasons:

Location ID 335952 is one of three active location entities for the same well pad and sits in the middle of the other two locations (please refer to the attached map and list of entities associated with this well pad):

- 1) ID 311852 is related to the active producing well on the pad.
- 2) ID 335952 is related to permitted locations on the pad.
- 3) ID 311855 is related to the active injection well on the pad.

In 2015, the conductors for the seven permitted well locations associated with 335952 were plugged. All the permitted locations associated with location ID 335952 are abandoned.

In November 2016, Whiting sold its interest in this well pad and lands below in entirety to Ursa Operating. The active wells and associated locations (311852 & 311855) were transferred to Ursa. Whiting no longer holds any interest or authority to perform any work on this well pad location.
