There are two erosion channels coming onto location by produced water tank. The channels are 6"-10" wide and 2"-6" deep. The breach in the ditch and berm is to the W along the S perimeter between meter house and Telemetry equipment.

Corrective Action: Install or repair required BMPs to comply with Rule 1002.f. Refer to the 1002.f guidance document for further details.
