Black Hills requests permission to add an air gap to the raw water inlet pipe to Pond 1 at the DeBeque Station to eliminate any potential of back-siphoning of water from the lined pond. The air gap will consist of a 1-inch wide by 1-foot long vertical slot cut into the top of the inlet approximately 6" above the spillway elevation, as shown in the attached engineering drawing.
