This Warning Letter is to inform you that SONTERRA ENERGY, L.L.C. (“Operator”) may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission (“COGCC”) and corrective action is required.

The COGCC has reasonable cause to believe that the Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. The Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

Alleged Violation(s) and Required Corrective Action(s):

<p>1102 Operations, Maintenance, and Repair</p> <p><u>Description of Alleged Violation:</u> Pursuant to Rule 1102.d., each operator with pipelines under COGCC jurisdiction shall become a member of the Utility Notification Center of Colorado and participate in Colorado's One Call notification system. Based on a COGCC records review, and consultation with the Utility Notification Center of Colorado, COGCC determined that Operator has at least one pipeline under COGCC jurisdiction and is not a member of the Utility Notification Center of Colorado, violating Rule 1102.d.</p> <p><u>Required Corrective Action:</u> Operator shall register with the Utility Notification Center of Colorado and verify membership by submitting a copy of the membership confirmation letter or a copy of the activation email provided by the Utility Notification Center of Colorado by email to Mark Schlagenhauf at:</p> <p>mark.schlagenhauf@state.co.us</p> <p>The lifetime membership fee is \$25.
