#### COMMENTS:

Great Western ("GW") will utilize a Flarecatcher unit designed by Pioneer Energy at their T&M Wildcat Production Facility. The facility has no existing pipeline infrastructure and in order to minimize the unnecessary waste of natural resources, the Flarecatcher unit will capture natural gas liquids (NGLs) from the produced gas stream and the tank vapors (via VRU). In doing so, the Flarecatcher unit creates two gas streams; the clean methane stream and the residue gas stream. A portion of the clean methane stream will be utilized as fuel for various sources at the facility. The remainder of the clean methane stream and the entirety of the residue gas stream will be controlled at >98% efficiency by an onsite enclosed combustion device (ECD). NGLs are stored in an onsite 18,000 gal pressurized tank and offloaded as necessary.

GW estimates gas production, at the Flarecatcher inlet, to be approximately 500 mscfd. A representative gas analysis from GW's Pierce 1-27 facility has been utilized to estimate emissions and demonstrate H2S composition.

The facility will be in compliance with the requirements of COGCC Rule 805.b.(1).
