Due to anti-collision needs and the variability of directional drilling, our as-drilled BHL could be different than the permitted. Per Rule 371.p Exception, compensated neutron logs have been run on the HOPPER 16C-22HZ well (API 05-123-43023).

The Top of Productive Zone provided is an estimate based on the landing point at 7777' MD.

Completion is estimated for Q3, 2017.
