COMMENTS:

A rise in Bradenhead pressure was logged on 5/21/2017 at approximately 14:45 and was subsequently reported (DOC# 401288865). The rise in Bradenhead pressure occurred within a 24 hour time-frame of frac operations taking place on an offset operator's well within 300 ft. Currently, an ongoing investigation is being conducted as to the root cause of the Bradenhead pressure event. The investigation will require adequate time to allow for the offset operator to begin flowback operations on their wells before Kerr-McGee's analysis can be finalized. Kerr-McGee will follow up with our findings in 60 days. Thank you.
