Comments: Improvements from the wellbore are an electric fence that falls approx. 186' South of the proposed well head within the 500' buffer area. An overhead power line exists approx 625' South of wellbore and 451' South of the well pad within the 500' buffer area. One of the Windfarm towers falls barely inside the 1000' buffer area. We will talk to landowner about repositioning electric fence. the only improvement within the 1000' or 500' buffer area is CR 30 the electric fence and the Powerlines.
