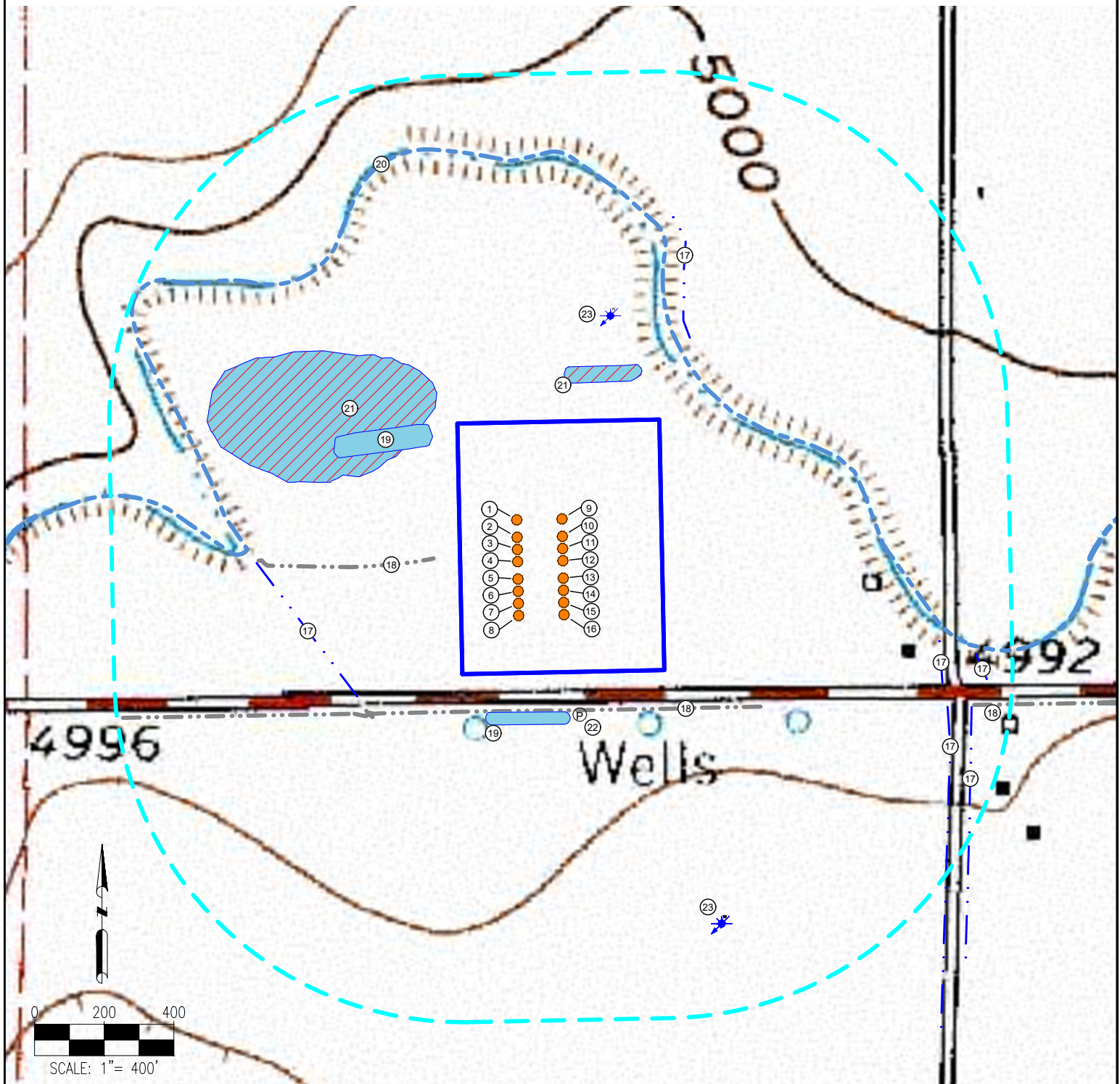


SASKATCHEWAN PAD HYDROLOGY MAP
