While conducting annual integrity testing on a partially buried vault, we observed that the vault was not able to hold freshwater we were using to conduct the test. The tank has been disconnected from production piping and all fluids have been removed.

Soil immediately below and around the partially buried vault will be field screened with a photoionization detector. If no impacted soil is observed, a soil sample will be collected from the base of the excavation created by the removal of the partially buried vault and submitted for laboratory analysis of all COGCC Table 910-1 analytes. If impacted soil is observed, it will be removed. Once all impacted soil has been removed, samples will be collected to prove successful removal of all impacted soil and submitted for the same analytes mentioned above.
