The bottom hole location is being extended 90', changing the westing footage to 370' FWL. Great Western will not perforate within 470' of the west line. Attached is an updated plat, directional data, and deviated drilling plan. The production casing design has also been updated to reflect the change in bottom hole location. Surface casing has been set and will be reported on the Form 5. Conductor casing will no longer be set.
