Corrective Action: Submit a Form 27 by 3/25/2016 to Northeast Environmental Protection Specialist Rob Young (rob.young@state.co.us). Remove debris and remaining equipment. Establish vegetation with total perennial non-invasive plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Final reclamation activities, including pit closure, shall begin immediately 3/18/2016

Date of Completion: 05/19/2017

Operator Comment: All debris and remaining equipment was removed by August 22, 2016. A Form 27 was submitted to Rob Young on April 13, 2017 and approved on April 14, 2017. All pits were then closed, stained soil spots were scraped and disposed of at the Buffalo Ridge Landfill, clean fill dirt and topsoil were brought in to bring pits to grade, and finally reclamation seeding with a straw mulch to finish the location out. All samples and backfill procedures were submitted to Rob Young on May 30, 2017. The Form 27 was officially closed out by Rob Young on May 31, 2017. Seed mixture was designated by the NRCS and approved by the landowner. Monitoring and management of weed and erosion control will continue until final reclamation has passed.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approved pending re-inspection of the FIR resolution acknowledges that the Oil and Gas Conservation Commission has received the Notice.
