Wesco had a spill along the Maudlin Gulch #18 flow line yesterday (June 7th). This spill path followed the same path as the spill in March, 2017. I filed a Form 19 spill report yesterday and a Form 27 remediation plan this morning. We plan to begin spill remediation this morning so are requesting Form 27 approval as soon as possible.

The spill flowed across the planed sample location for the March, 2017 spill, so I may delay sampling until the June 7th spill has been remediated.
