The Schwake 1 WP-M008 is a gas storage monitor well within the East Cheyenne Gas Storage Facility. The downhole pressure recorders of the Schwake 1 WP-M008 well were recently pulled & recalibrated. The well was also logged with a pulsed neutron, cement integrity, temperature & casing inspection (CAST) tools. Tubing & packer were re-run to new setting depths because of the well work. The logs & wellbore diagram are being submitted to update the well information.
