He told me it was a screeching sound, like metal on metal. The pumpjack was on a timer and not in operation while on site (Did not use noisemeter, Wind in excess of 15 mph). I told him I would return if I needed to take noise readings and that I would talk to the Operator. I would have him turn on the pumpjack, so we could hear the sound. I could not detect any unusual odor Site is on the edge of Lobach Farm. Did an inspection and was off site at 11:40 am.
