Basis for Review: Equipment is not owned or controlled by the operator

Operator Comment: The riser documented is not part of The City and County of Denver oil and gas program. This riser is actually on an abandoned Platte Valley Gas Purchasing system owned by Anadarko Mid stream. We are working to get them out to remove 3 risers associated with this line on this section. See attached Platte Valley Map with abandoned line thru half section of 1 2S 66W. The tank battery was actually NE of the well per some old maps.

COGCC Decision: Approved pending re-inspection

Basis for Review: Action requested was already completed prior to the inspection

Operator Comment: All documents associated with this well have disappeared from the COGCC database. We have been finding that our well document haveh pages of documents that belong to other wells, operators, in other counties etc. The COGCC scout card shows the well as PA, with the correct date. Since this well was plugged in 1994, information is scarce. We did find the attaced Form 4 submitted for the PA in 1994, but not the approved one. There was no Form 6 in 1994. I believe the state approved the Form 4 for the final because the PA date on the scout card is correct.  
We are researching the soil problem, as you may have noticed this field has many bare spots, due to the sandy conditions. There is wheat in there now and we do not want to destroy crops at this time. We are in contact with the tenant farmer (surface is owned by The City) to see if he thinks there is a problem. He was the original famer on this section before DIA.

COGCC Decision: **Not Approved**

COGCC Supervisor: There is no indication that the reclamation preparation or evaluation has been completed. The CA for the reclamation of the site still stands. COGCC will seek and evaluate the form 6S hard copy documents.
