Removal on slightly impacted soil has been scheduled.

OPERATOR COMMENT AND SUBMITTAL

Comment: Cause of the problem -- we think a siphon break in a 3" siphon line was temporarily blocked. A small amount of fluid from the water tank come out the top of the siphon line and ran down the sides of the line and collected in a low area adjacent to the water tank. The low area was already full of rain water.
Corrective action plan -- all of the water in the low area has been picked up. On Thursday, June 22 a crew will be onsite and will remove any stained soil and replace it with clean fill dirt.
