Remove the culvert and perform reclamation in accordance to COGCC 1000 series reclamation rules. Establish vegetation with, non-invasive, uniform plant cover of at least eighty (80) percent of reference area levels. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Reclamation activities shall be complete no later than 11/15/2017.
