Comment:

Battery location does not meet reclamation standards. It does not appear reclamation activities have been performed at the battery location as gravel is still present with little to no vegetative growth that is representative of reference areas. Culverts remain throughout different access points which may need to remain for an access point to a road that appears to be used by the surface owner. The referred road in the previous sentence appears to be used by the surface owner to access a pivot irrigation field to the north which was also used for another BBC location (API #123-23118). Please refer to the attached inspection photo in Document #682402347.

Corrective Action:

Remove culverts and perform reclamation in accordance to COGCC 1000 series reclamation rules at the battery location. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. The prime time frame for a spring 2017 seeding has passed, to take advantage of a fall seeding, revegetation activities shall be complete no later than 11/15/2017.
