Comments The Fauver #1-20 vertical pilot well will be tested by swabbing over a period of +/- 30 days. The well will be swab tested into 2 frac tanks and oil and water production will be monitored. The purpose of swab testing is to establish oil production from the Niobrara Formation. If oil production is established, horizontal development will follow: horizontal well will be permitted and permanent production facilities will be set.

This location has moved 500' north from the previously permitted location for the Fauver #1-20.
