As a correction to the previously submitted Form 2 the pad and has not been built. Prior to the expiration a new 2A will be refiled prior to constructing the pad. The pad is located within a sensitive wildlife habitat area. A closed loop system will be used so no pit will be used.

As a correction to the previously submitted Form 2, oil-based mud will not be utilized for this well.
