Date **07/21/2017**

Comply with the 1004 Reclamation Rules. Perform noxious weed control. Remove gravel and debris. Recontour and decompact soils by cross ripping to a minimum depth of 18 inches. Install stormwater BMP's and stabilize the disturbed soils with a certified weed free mulch or equivalent method until vegetation establishes.

Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS.
