Location PA'd 10/27/2014. All reclamation work should have been conducted by 1/27/2015 on cropland. Musk and Canada thistle present at tank battery and access road. These are Colorado State listed noxious weeds and need to be managed.**

Corrective Action:	Perform reclamation in accordance to COGCC 1000 series reclamation rules at well and access road. Remove and manage weeds. Work shall be completed by 7/31/2017. Ensure temporary stabilization controls are in place until more permanent vegetative stabilization has established. Reclamation activities shall be completed no later than 7/31/2017.
