Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the E/2 Section 16, E/2 Section 21, N/2NE/4 Section 28, T 2N, R64W, creating a 720-acre wellbore spacing unit for the Niobrara formation. - Map & plat illustrating proposed wellbore spacing unit.

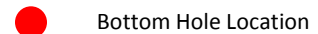

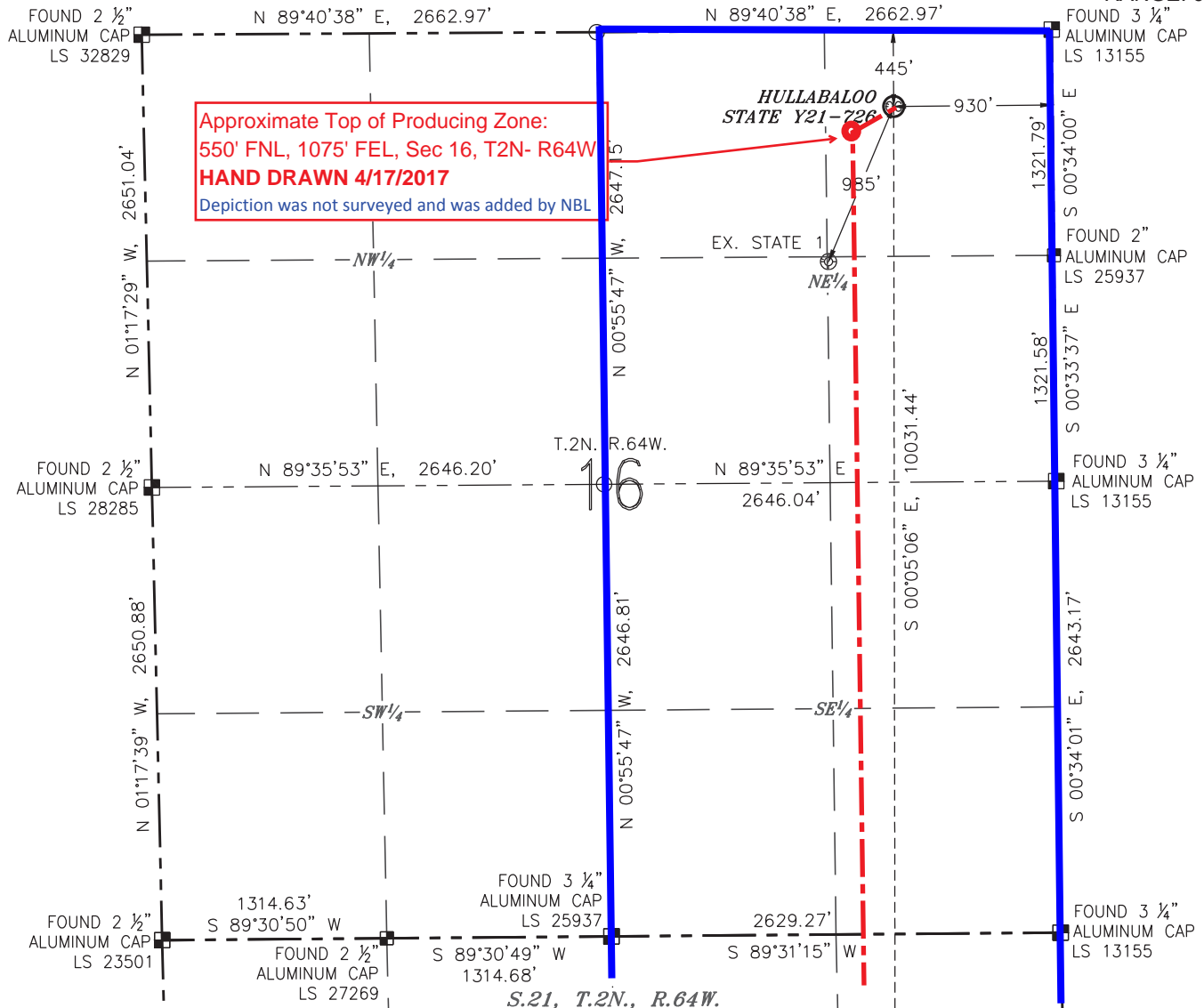

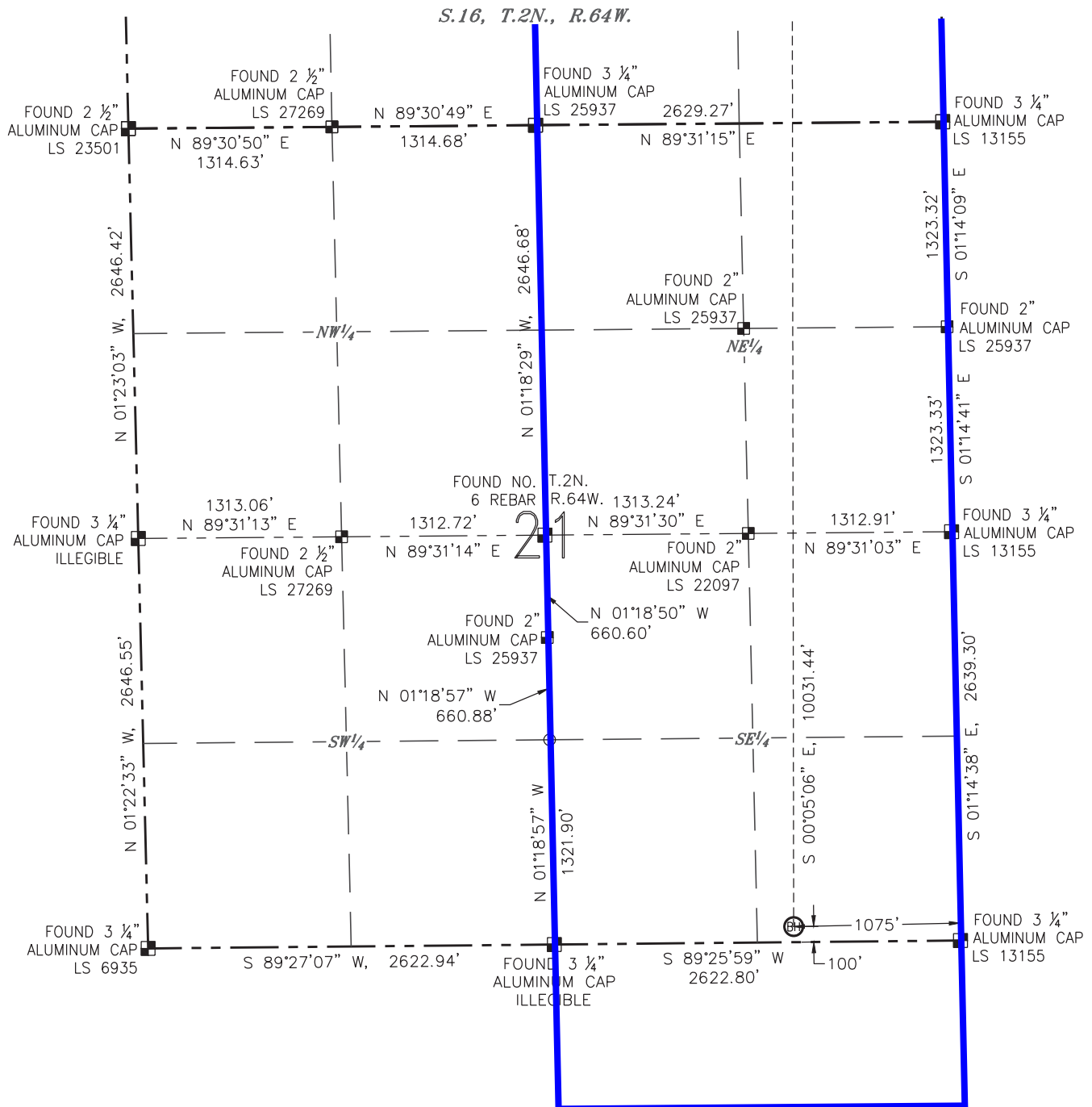
