Comment: [This location does not meet reclamation requirements. Equipment \(meter shed\) remains at battery location. Battery location remains bare and exposed soil and needs stabilization controls. Additional tank battery facilities \(Ritter C18-16\) have been constructed next to the Ritter C 18-10 battery, preventing location from being returned to the surface owner for agricultural use.](#)

Corrective Action:	Comply with the reclamation rules to remove (regardless of ownership) all equipment within three months of plugging (5/14/2014) the associated facility. All work should have been conducted by 8/14/2014. Remove equipment from battery per 1004.a and implement stabilization controls at battery by 8/3/2017. Manage and maintain until facility can be returned to agricultural use. Perform reclamation on the well location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Revegetation activities shall be completed by 11/15/2017.	Date	08/03/2017
