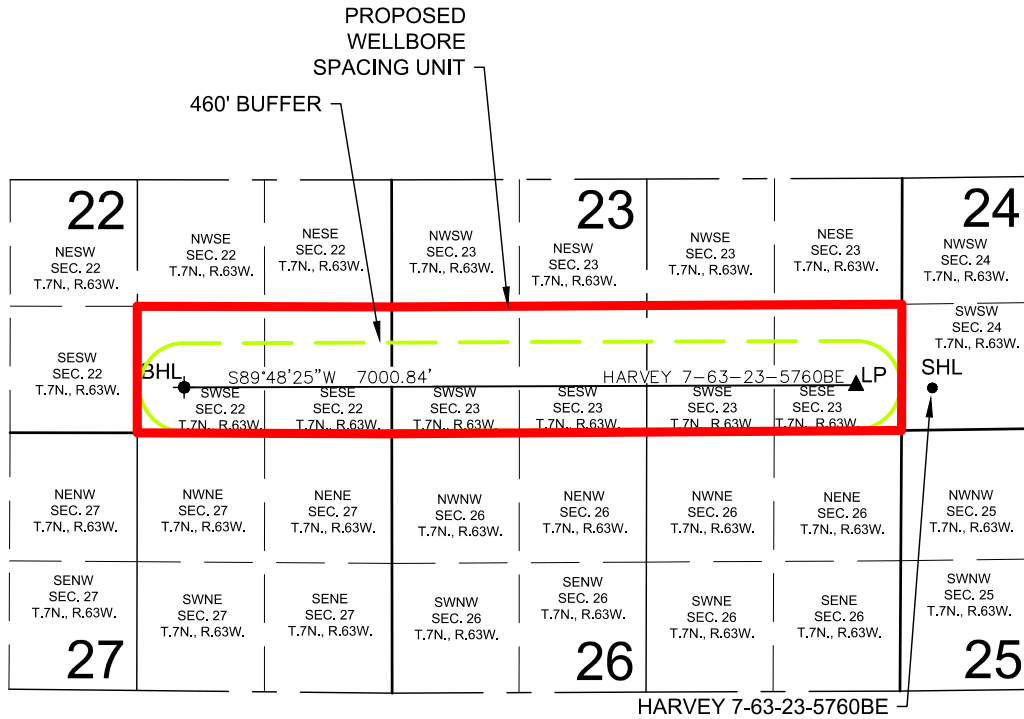

SEC. 23: S2S2



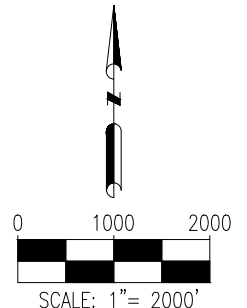
WELL HARVEY 7-63-23-5760BE TO BE LOCATED 440' FSL AND 319' FWL, SEC. 24, T7N, R63W
