Comply with reclamation rules to remove, all debris, abandoned gathering line risers, and flowline risers, and equipment within three months of the August 23, 2015 plugging the associated well. All work should have been conducted by November 23, 2015. Operator must now at a minimum abide by the May 2, 2017 Flowline or Pipeline NTO. Photos and/or GPS of the various gathering line risers, and flowline risers are attached.

All Risers/ Flowlines/ Pipelines must abide by the Phase II of the May 2, 2017 Flowline NTO and should have been removed by June 30, 2017.
