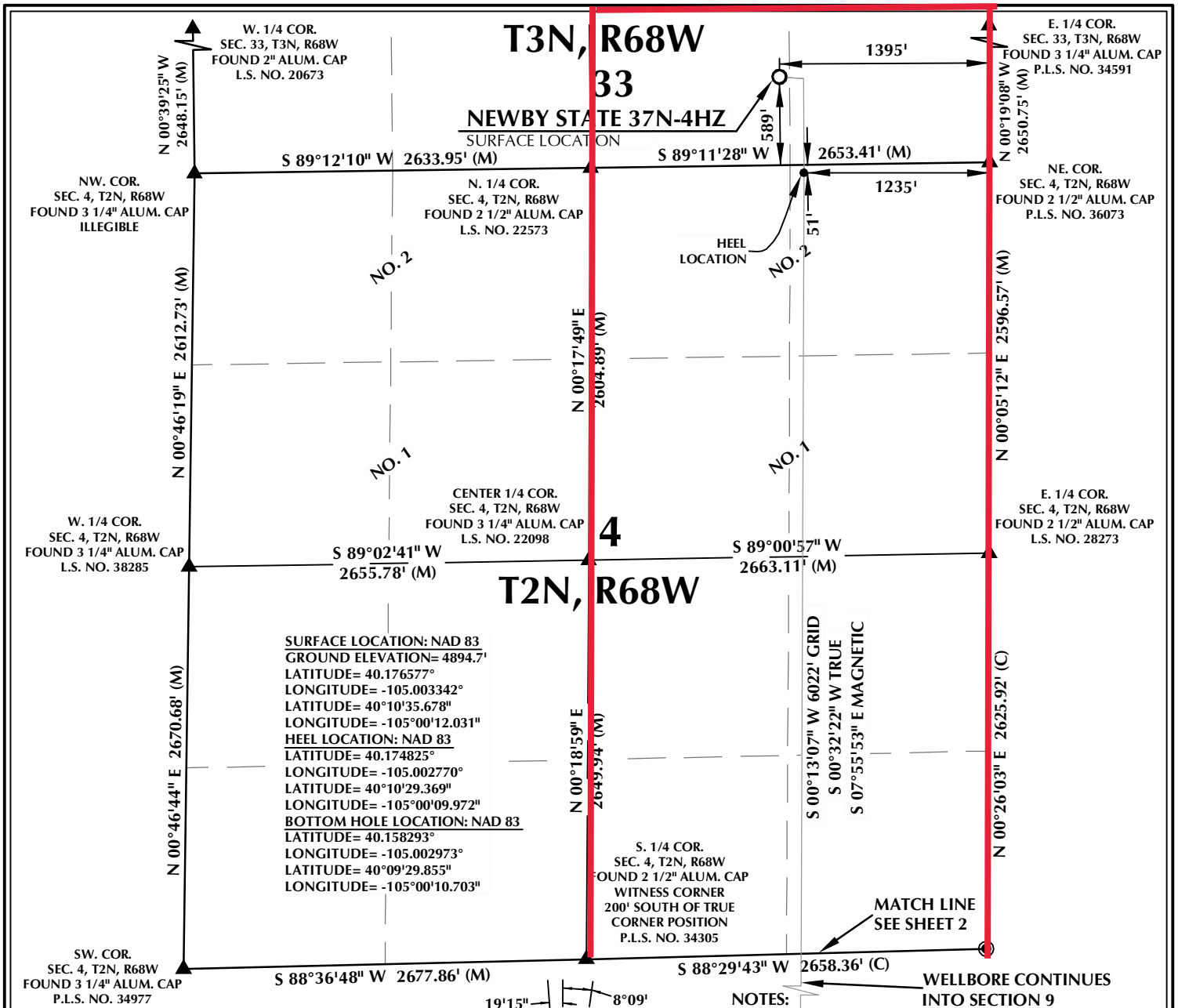

PROPOSED SPACING UNIT



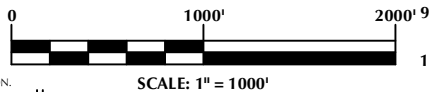

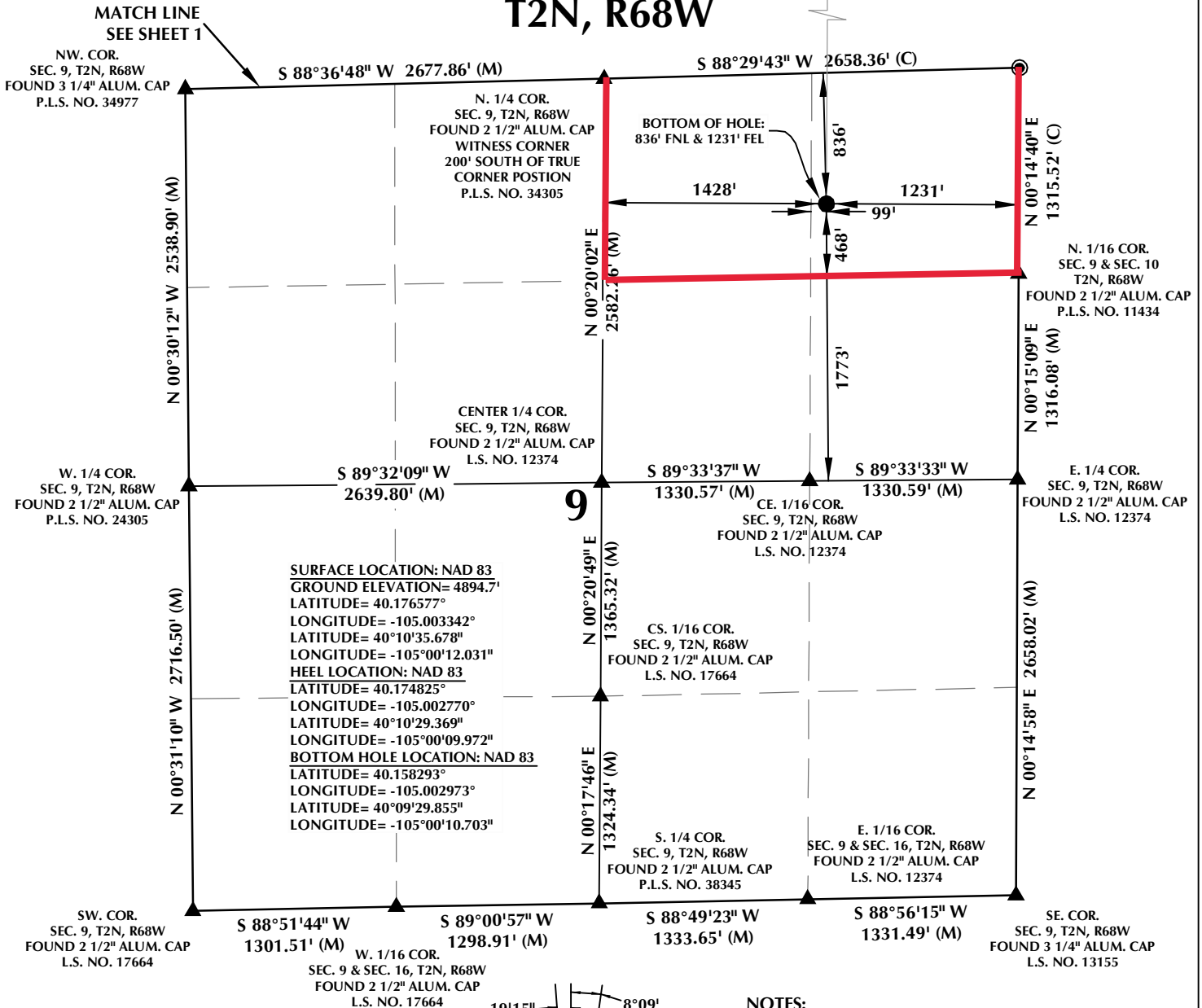

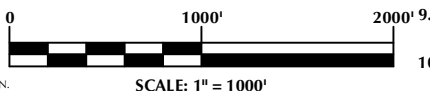
