**General Comment:**

COGCC Environmental inspection. Follow-up to 11/1/2016 field inspection report (doc #679500181) and Remediation Project #9966. Well was PA on 5/4/2011, per Well Abandonment Report (doc #1636713). Form 27 required by 11/1/2016 inspection report was provided and conditionally-approved in December 2016 (doc #2087288). Pit closure documentation for related pit Facility ID #112001 has not been provided to COGCC Area EPS.

Former pit and well pad areas do not comply with 1000-series Final Reclamation requirements (see photos). Facility is being referred to COGCC Area Reclamation Specialist Aaron Trujillo.
